# Phase 2: What did the community engagement process look like?

- 6 Community Advisory Committee meetings
- 6 Open community meetings
- Focus groups at gatherings in target communities
- 200 + residents were engaged
- Four priority areas for funding were identified





# **Draft** principles guiding the Boston Children's DoN CHI funding strategy

Improved health and well-being for children and families is when:

- 1. All children and youth, **especially those most negatively impacted by racial and ethnic health disparities**, have the opportunities and means to grow into healthy, happy, productive adults.
- 2. Children and families are empowered and supported to advocate for good health and the things that matter for good health.
- 3. Businesses, government, communities, organizations, and individuals work together to build thriving communities for children and families.
- 4. What's **already working** to reduce racial, ethnic, geographic, and economic inequities in health for children and families **is supported and improved**.
- 5. Social and community health services for children and families are efficient and effective.
- 6. Policy, system, and environmental changes will have long term benefits for children and families.

### **Boston Children's Transforming Tomorrow**



#### Why is Boston Children's Hospital investing funds back into the community?

Boston Children's received approval for its building project through a state program called Determination of Need (DoN). This program is administered through the Massachusetts Department of Public Health (MDPH). Approval is required for all health care facilities that make a substantial capital expenditure. One condition is that the applicant creates a plan to spend 5 percent of the maximum capital expenditure (\$53 million in this case) on community health initiatives. Boston Children's will use the funds to improve the health and well-being of children and families.

#### How did Boston Children's get community input?

Boston Children's held six facilitated open community meetings, a city-wide meeting and focus groups from July through September 2016. For more details, see our summary.





Term	Definition	
Principles	Shared values essential to achieving improved child and family health and well-being in the community	
Goal	What we hope to achieve	
Strategy	How we hope to achieve goals (cross cutting and priority area specific)	
Resources	Non-monetary supports needed for strategies to be successful (i.e. training, coaching, communications, evaluation)	
Funding amounts	Monetary amounts that will be made available	
Funding mechanism	Ways funds will be made available (e.g. BCH/OCH invitation, RFPs)	
Funding criteria	Standards that need to be met to receive funds	
Dissemination strategy	Plan of action to get the word out about funding opportunities	

### 4 priority area working definitions

Priority area	Working definition
Mental and behavioral health*	The states of well-being in which a child and family realize their abilities, can cope with normal stresses of everyday living, can learn and work productively and fruitfully, and can make a contribution to their family and community.
Stable and affordable housing*	Stable and affordable housing includes freedom from the risk of losing housing, the ability to maintain quality housing, and the availability of resources and supports to ensure secure access to quality housing for children and families.
Infant, youth, and families systems of support**	Safe, stable, quality, and equitable opportunities for playing, learning, and working are available for infants, youth, and families.
Safe and healthy communities**	Communities where children and families have opportunities and access to the means and resources for their health and well-being.
